In very rare cases, a researcher deals with a biography that includes all the events of life, presented in the "first person" (Kozlova, 2004).

Since the 70s XX century in the wake of the revival of interest in the biographical method, its scope expanded significantly. Currently, it is used where the researcher is interested in the subjective experience of socio-historical processes (wars, revolutions, crises, migrations) and certain phases of human life (childhood, illness and death).

At the same time, its use is important where the main database is first-hand information about individual social experience - actions, events, emotions. It is valuable precisely as the subjective point of view of a social "actor", therefore its main source in the biographical method is personal documents (life histories, written autobiographies, diaries, letters, family archives, photographs, pedigree dossiers, etc.) (Golofast, 1995).
